




OUR STUDENT PROGRAM


Revenue



Total Revenue 2019 \$312,345.00

In 2019 we experienced a dip in revenue compared to the previous year. Factors include a 44% decrease in revenue from **Baby Bottle Campaigns** and a 98% decrease in Angel donor revenue. Increased emphasis for the upcoming year is on connecting with more potential Angel donors and our community businesses for support.








Expenses

Management & administration 29.9%




2019 showed an increase in expenses compared to the previous year. This has been attributed to increasing demand for our services (62% increase in requests for admission this year).

Total Expenses 2019 \$365,228.00

To address this demand we hired temporary workers and introduced our Day Program, expanded our services for navigating community resources for our waitlist, grew our Wellness Program & Food Security Programs, and increased services to our Seeds of Hope Program.


